Personal Interview

Once the application has been submitted, all the provided documents will be analyzed and it will be determined if the candidate will be scheduled for a personal interview. The objective of the interview is to take into consideration the candidate's motivation, evaluate if the profile is appropriate to participate in the program (leadership, communication and teamwork skills) and to verify the level of English proficiency (C1).

Notification of the candidate

Once the admission decision has been made, the candidate will be notified if he or she is accepted or not by post. Admitted students have a period of 15 days upon receiving the letter to reserve his or her space.

Tuition

The cost of tuition is €26.000**

10% of the tuition must be paid as a deposit to reserve the space. Within a period of 10 days upon receiving the admission letter, the candidate must make a €2,600 transfer to the University of Navarra – ISEM to one of the following bank accounts. The amount of the reservation deposit is not refundable if the student finally decides not to make the master.

Payment Calendar

Tuition fee €26,000

- -Reservation deposit: €2,600* within fifteen days from date of admission notice
- -1st payment: €14,400 at the beginning of the academic year
- -2nd payment: €9,000 in the middle of the academic year

The payment should be made by bank transfer to the University of Navarra-ISEM.

* The amount of the tuition fee is not refundable is not refundable or transferable for future editions if the student finally decides not to take the master's degree.

Financing and Scholarships

ISEM Fashion Business School has a variety of financial aid options available to students, from bank loans to agreements with companies with the aim to economically support candidates who demonstrate that they are deserving of them. The scholarship beneficiary must assume the commitment to carry out collaborative tasks with the institution. The repeated lack of commitment and responsibility would lead to the cancellation of the scholarship awarded and the refund of its amount.

ISEM admits that the candidates present a payment schedule, as long as the last term is made no later than April.
